Travel Conditions (Summary)

This document is a part of the travel transaction conditions explanation document stipulated in Article 12-4 of the Travel Agency Law and the contract document stipulated in Article 12-5 of the same law. Please check the document explaining the detailed travel conditions before applying for the tour.

This tour is planned and implemented by Meitetsu Kanko Service, Inc. The contents and conditions of the tour contract are as follows. The contents and conditions of the tour contract shall be in accordance with the pamphlet, the tour condition document to be separately handed out, the final itinerary to be handed out before departure, and our General Terms and Conditions for Travel Agents. If you would like to request a copy of the Company's travel business terms and conditions, please request it from the Company.

● How to apply and when to sign the contract

- (1) To apply for a trip, please fill out the prescribed application form and submit it with the application fee. The contract will be concluded when the Company accepts the contract and receives the application fee. In the case of reservations made by telephone, mail, fax, internet, etc., please complete the application procedures within 3 days from the day following the day on which the Company notifies you of its acceptance of your reservation.
- (2) The application fee will be treated as part or all of the "tour fee to be paid" or "cancellation fee" or "penalty fee".
- (3) When a travel application is made by the person responsible for the contract as a representative of the travelers who comprise the group/group, the person responsible for the contract is deemed to have all the rights of representation regarding the conclusion and cancellation of the contract, etc.

● Payment of application fee and trip fee

- (1) The following application fee per person must be paid at the time of application.
Less than 30,000 yen..... 5,000 yen or more up to the trip cost
30,000 yen or more but less than 60,000 yen..... 10,000 yen or more up to the trip cost
60,000 yen or more..... 20,000 yen or more up to the trip cost
- (2) The remaining balance must be paid 21 days prior to the day before the start of the tour (or by the date specified by the Company if the application is made at a later date).

● Included in the trip price

- (1) Transportation, lodging, meals, sightseeing fees, and consumption and other taxes as specified in the itinerary.
- (2) For courses accompanied by tour guides, tour guide expenses and gratuities necessary for group activities are included.
- (3) In principle, the above expenses will not be refunded even if some of them are not used for the customer's convenience.

● Cancellation charge

- (1) The customer may cancel the tour contract at any time by paying the following cancellation fees

Release Date	Cancellation fee (per person)
From the day before the trip start date until the day that falls on the 8th day after the 20th day (the 10th day in the case of a one-day trip)	20% of trip fee
The day that falls on the seventh day after the first day of the tour until the day that falls on the day before the second day before the first day of the tour	30% of trip fee
One day before the trip start date	40% of trip fee
On the day of the trip start date	50% of trip fee
No-show or after the start of the trip	100% of the tour fee

● Special compensation

We will pay the pre-determined amount of compensation and compensation for damages to your body or baggage caused by a sudden and accidental external accident while you are participating in the tour.

● Itinerary Guarantee

In the event of an important change in the contents of the contract described in this brochure as stipulated in our General Terms and Conditions of Travel (Article 29, left hand column of the attached table in the section for organized tours), we will pay compensation for the change as stipulated in the same article.
